A Message from Dr. Stein

October 25, 2023

Dear Students,

As you know, we have been working over the past year to redefine our undergraduate residential experience. I write today to update you on the creative teams, last week's Board meeting, and next steps, including the following key takeaways:

1. Students who have already declared a major or will declare one from the existing course catalog prior to August 2024 will be able to complete their major on schedule through courses offered at Mary Baldwin.
2. We will introduce a new liberal arts general education program, along with existing, reconceptualized, and new majors in four academic pathways: Health Sciences, Education and Society, Business and Technology, and Creativity and Design.
3. No immediate changes will occur in employment, and we are working with every affected faculty member to navigate future changes in responsibilities and explore alternative teaching opportunities at Mary Baldwin.
4. Please plan to attend our next student town hall on Thursday, Nov. 2, at 7 p.m. in Francis Auditorium to discuss these changes in greater depth.

Creative Team Updates

The Academic Portfolio creative team presented final recommendations to the Board of Trustees regarding the proposed list of discontinued majors; continuing majors; and consolidated, reconceptualized, and new majors. The Engaged Student Experience creative team presented recommendations to expand students' on- and off-campus learning experiences through an engaged student experience framework, internships and study/work away, and a new residential college initiative to link living and learning on campus.

Board Actions

After months of research, assessment of student demand for majors, community input, market analysis, and dedicated effort from our creative teams, the Board of Trustees voted to endorse a new academic portfolio that weaves together the liberal arts, updated majors, integration of technology and data, and enhanced preparation for lives of personal and professional success. After careful consideration and lengthy deliberation, the Board of Trustees voted to:

- Endorse a new 10-course liberal arts-focused general education curriculum

- Create a new undergraduate residential academic portfolio, consisting of 12 continuing, three reconceptualized, and three new programs categorized within four industry-aligned academic pathways:

- Remove a 2017–18 provision of the Faculty Handbook related to separation of tenured faculty when an academic program or department is eliminated (5.3.3.2).

What Does This Mean for You?

I know many of you will have questions and concerns about how this will affect your major, so I want to make something absolutely clear: Regardless of program decisions, every student who has already declared a major or who declares a major this academic year, will be able to complete their degree in that major on time and with Mary Baldwin faculty.

We are committed to ensuring that each of you has the information and support you need on your uninterrupted path to graduation. In the coming weeks and months, academic leaders will be reaching out to each student whose declared major is being discontinued with information about next steps, including an individualized degree-completion plan. For now, students should contact their academic advisors or department chairs with any questions regarding degree completion.

Impact on Faculty

I want to directly address how these changes will affect employees and reiterate that no immediate employment actions will be taken. To be clear, faculty in affected departments have been asked to continue their current responsibilities throughout the ongoing degree completion for all students who have already declared majors or who will do so by the end of this academic year (a process that could run through spring 2027). Additionally, although department closures mean that teaching responsibilities may eventually change, we anticipate that affected faculty who remain employed at MBU will retain their tenure status and rank.

We are working with each of the 8–10 affected faculty members to navigate changes in responsibilities (including teaching the remaining students in their major and/or possibly teaching in the new general education program), provide transition assistance, and explore options for remaining at Mary Baldwin (such as the Director of Teaching and Learning and Director of Institutional Research and Student Learning Data positions just posted at the university). Since Monday, Dr. Paul Menzer, dean of the university faculty and vice president and dean of the Gold College of Arts and Sciences, and I have met with affected faculty in the discontinued majors listed above and also with the Faculty Council to explain the Board's actions, review employment options going forward, and answer questions. Finally, no decisions have been made yet regarding academic minors.

Throughout this process, we remain committed to transparency and open communication. Thank you to those of you who attended the student town hall earlier this month. **Please plan**
